

DALEY BILL SIGNED INTO LAW



In 2021, I introduced legislation to extend the Michigan Agriculture Environmental Assurance Program (MAEAP). This program has proven to be an invaluable tool for Michigan farmers and I am happy to announce the bill has now been signed into law by the governor.

As a farmer myself, I have seen firsthand how MAEAP can help farmers stay within state and federal guidelines and adopt environmentally friendly practices that reduce erosion and runoff into ponds, streams, and rivers.

The newly signed law renews MAEAP and extends the sunset of the Freshwater Protection Fee that funds the program for another four years with no change to current fertilizer license and registration fees. The existing sunset was set to expire this year.

DALEY SUPPORTS UNLOCK MICHIGAN PETITION

Two days after the Board of State Canvassers certified the Unlock Michigan signatures, the Senate voted to approve the measure to repeal the Emergency Powers of the Governor Act of 1945.

The petition drive was a response to the governor exceeding her executive powers during the coronavirus pandemic in 2020, establishing policy for COVID-19 without input from the Legislature and acting unilaterally.

The Michigan Supreme Court ruled Gov. Whitmer's actions illegal and declared the 1945 law unconstitutional. I voted to approve the Unlock Michigan citizen-led petition to ensure no governor can utilize these unlimited powers again and ignore the voice of the people.




DALEY OPPOSES VACCINE MANDATES



I am opposed to the federal government's vaccine mandate. The decision to receive – or not receive – a vaccine is an individual decision and should not be mandated by the government. This mandate compromises our individual freedoms and forces our workers into an ultimatum. The American people should never have to choose between their personal beliefs and putting food on the table for their families.

I am proud to co-sponsor Senate Bills 600-603, which would prohibit public schools or DHHS from requiring an emergency-use COVID-19 vaccine to attend or participate in regular school activities, would prohibit schools from discriminating between vaccinated and unvaccinated students and would allow schools to establish a waiver process for students to opt out of mask-wearing or testing.
